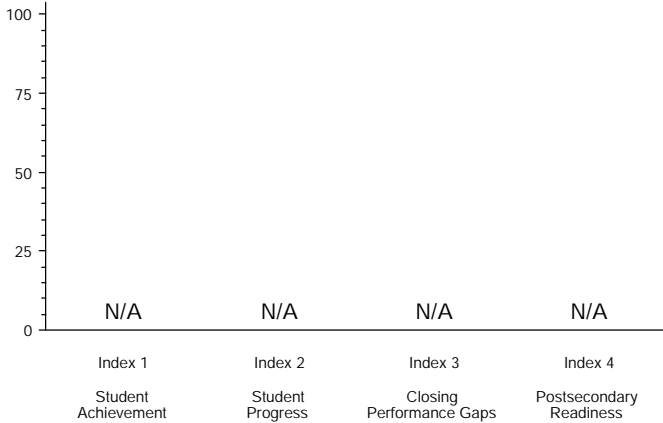

The bar chart below illustrates the index scores (ranging from 0 to 100) for this campus for a given index.
